Dear Ms Dorries

I write to you in frustration at the lack of political engagement between your office and those campaigning on behalf of people infected and affected by the contaminated blood scandal.

On 28 January you and the then Cabinet Office Minister Oliver Dowden met with many campaigners, including myself, to discuss issues relating to the Infected Blood Inquiry. These included the desperate need for fair financial support as well as specialist psychological provision. We have heard nothing since that meeting.

On 4 March, The Haemophilia Society wrote to you asking for urgent action in funding specialist long-term psychological support for victims of the contaminated blood scandal and their families. We did not get a reply.

Three weeks ago, on 14 April, I wrote to you requesting clarification over Government advice on shielding people with HIV which appears to contradict the advice of expert HIV organisations. You have not yet responded.

Your predecessor, Jackie Doyle-Price, with whom we also had meetings in early 2019, also failed to act on our concerns about lack of mental health support. You can understand why this community feels let down by meetings with politicians which, time after time, fail to result in any meaningful action.

While this is clearly an extremely challenging period for your department, the Government and the country as a whole, the needs of those infected and affected by the contaminated blood scandal have not gone away. Indeed, the swift action taken by the Government in relation to COVID-19 and the huge sums committed to combat our current crisis reminds us that, if there is sufficient political will, it is possible to tackle problems very quickly.

In the meantime, I look forward to receiving a response to our letters. Your words at the meeting of 28 January were very warm, which makes my disappointment at your lack of action all the more acute.
